8. Administrative Business:

A. Proposed Shoreland Amendments to Appendix K Land Use Ordinance: First review

The CEO prefaced the review by reporting to the board that the town council has issued a directive to the board to propose amendments to Appendix K that will prohibit retail marijuana establishments and social clubs. The board was provided with a draft amendment that will be discussed at the next meeting.

The CEO explained the purpose of the several proposed amendments to Appendix K dealing with shoreland standards. Dimensional standards are being amended pursuant to preliminary approval received from DEP. Additional changes are proposed to bring the ordinance into compliance with changes made to Chapter 1000, DEP's shoreland rules.

The board agreed to all proposed changes, including the recommendation that timber harvest regulation in the shoreland areas be turned over to the Maine Forest Service.

A public hearing was scheduled for June 14th at 6:30PM.

9. Discussion: The board was provided with invitations to a meeting of the Friends of Silver Lake. A DEP official will be talking about lake water quality management.

Member Johnson expressed his interest in interviewing each board member for the Heart and Soul program.
